Mayor Lambeth called the special meeting to order at 5:00 pm stating the purpose of the meeting was to select one architectural firm to begin contract negotiations to develop the Ocean Front Park. Notice of the meeting was posted at Town Hall on 7/22/10 thus meeting statutory notification requirements. At the last meeting, Council requested pricing proposals from two architectural firms. After the meeting, Brian Cox of Engineering Services notified him that per G.S. 143-64.31 (Mini-Brooks Act) regarding selection of architects based on qualifications only, Council must choose only one architect, not two, for contract negotiation.
