By motion made, seconded and carried the agenda for the September meeting were adopted.

By motion made, seconded and carried the minutes for the August meeting were adopted.

OLD BUSINESS:

- 1. Sand Fencing at Riggings. John advised he has checked out the sand fencing and found it to be falling apart. He will advise the Riggings of the need to remove the pieces.*
- 2. Keep of the dunes signs. John has surveyed the beach and reports that ten (10) of the signs have been lost and need to be replaces. In total about 30 or so signs need to be either replaced or upgraded. He will advise Sonny of the need to take care of this problem.*
- 3. Beach Nourishment. Chuck reported that there is a meeting tonight to finalize the project. This year Kure Beach did not receives federal and state funding for the project but Carolina Beach has received sufficient funding. Hopefully the commissioners will vote to accept the proposal from Carolina Beach and the County to ensure the nourishment project.*
- 4. Brochure Modifications. Phyllis reported that she had received a work up for the revised brochure from Shannon (Island Printing 4 U). The committee reviewed the proposal and discussed improvements to it. The committee is required to obtain at least two (2) bids for any project. Phyllis will contact Southern Signs and request a bid and work- up from them. The projected cost for the brochure from Shannon is 500 brochures for \$205.00. This is a regular sized sheet with a triple fold.*

NEW BUSINESS:

- a. Sea Oats. Mike reported that Carolina Beach has sufficient sea oats for us to purchase at a very reasonable cost. He will report back on what areas will need to be replanted and how many sea oats will be required.*
- b. Beach Sweep. Phyllis reported that the UNCW Honors Group performed a beach sweep, for the 13th year, and collected condoms, cigarette butts and some garbage. We thank each and every one who participated. Each year, on the last Saturday we participate in*

the Nationwide Keep America Clean project. This year the date is Sept. 29th. We will meet at the Pier at 8:00AM to sign in the volunteers, hand out gloves and bags and advise what areas should be worked. As Tony will not be able to attend, Ed Kennedy from the Fire Dept. will help us with the table, chairs, banner, and checking on the volunteers, collection of garbage bags. We thank Ed for his help. Phyllis will request funds for purchasing water, snack bars, gloves and bags. The cost for these items should not exceed \$75.00.

- c. New Members. The committee has received applications from Pat Triplett and Susan Walters. Priscilla will call both ladies and invite them to the October 2nd meeting. The Committee has two (2) open slots to fill. One is a permanent seat and the second is for Alternate.*

The meeting adjourned at 4:50PM. The next scheduled meeting will be on October 2nd at 3:30PM at the Town Hall.
