

*KURE BEACH
BEAUTIFICATION MEETING
NOVEMBER 6, 2006*

The meeting was called to order at 4:30 PM at the Town Hall with the following in attendance:

Chair Gordon introduced Heather Burkert of Burkert & Co. Landscape Architecture & Land Planning. She presented the committee with a outline of the services that can be provided regarding the Town Hall campus, Avenues E, I and 6th, etc. Regarding the Town Hall Campus, this would include the war memorial as well as a master-planting plan.

Barry Nelder introduced Ryan Bradshaw of Heather Lane. He is in the planting business and is willing to act in an advisory position regarding the areas the committee is interested in upgrading. He will draw up a proposal regarding the front of the Town Hall.

Saturday, November 11th will be "Tree Planting day". We need volunteers to assist in the planting, to majority of which will be on 6th. There are a few additional sites, and the volunteers will be steered toward one of them. The trees will be delivered Wednesday. John and Barry will obtain coffee and donuts for the planters.

But Nelms has planted line of nine (9) palm trees along the medium of 6th, St. south. Councilman Lambert, at the October 9th meeting advised the committee that Mr. Nelms has requested permission to plant palm trees on the medium in front of his home. The Committee agreed to three palms in a cluster provided Mr. Nelms paid for them, planted them, where the committee directs, and cares for them. They must be palms that are native to Kure Beach. This was not adhered to. Therefore the following motion was made, seconded and carried:
