KURE BEACH COMMUNITY CENTER MINUTES/JANUARY 6, 2009

The first meeting of 2009 was called to order at approximately 10:10 a.m. with a prayer said by Frances Regan. Members present were: Frances Regan, Jean Martin, Jeannie Gordon, Jerry Smith, Nancy Hughes, Jackie Phillips, Linda Newton, Lore Eccleston, Pam Bramhall, Irene Barber, and Pat Slachetka

The first item of business conducted was to approve the minutes of October 7, 2008. Since our Committee did not meet during the months of November and December, our minutes had to wait to be approved until today.

After a very inclusive report by Jeannie Gordon, our Treasurer's report was accepted. The year-to-date figures for Expenditures for Fiscal Year (July 1, 2008 to June 30, 2009) is \$2,539.48 compared to the total budgeted amount of \$8,465.00. Our Income figures for the same time-period looks really good. The total budgeted amount is \$10,220.00 and our Year-to-date figure stands at \$6,129.60.

At this moment, Jerry Smith asked to make an announcement. Jerry wished to submit her resignation from our Committee due to some very serious health issues. After discussions, Frances asked Jerry to please continue on the committee because she felt that keeping Jerry involved could be a good thing for her. All members agreed and voiced their willingness to help Jerry in any way they could. Jerry agreed but said that should she feel unable to continue, she would then officially resign.

At this point, Jerry ran-down her duties as Chairperson of the Dance Committee. All members will do all they can to be sure we keep the dances (Square Dances and Tony & Diane) since these are a good source of revenue as well as being good community events.

The treasurer, Jeannie Gordon, mentioned that our electricity bills seem to be very high and thought that perhaps we need a new thermostat. Frances mentioned that she had discussed this with Sonny Beeker in the past and Sonny mentioned that the problem is that the building is very old and not well insulated.

AWARDS DINNER: Plans for the upcoming Awards Dinner were confirmed. Date of dinner will be: March 21, 2009. Nominations are due by: February 28, 2009.

<u>CATERER</u>: Jerry Smith, Pat Slachetka and Irene Barber will approach Bon Appetit in the coming week to see if they will, once again, cater our dinner and hopefully we can convince the caterer to keep the same price per person as last year's event which was \$13.95 per person. Pat suggested that we try to get it a bit lower....

Jerry mentioned that we might be able to get some young girls that work at Kate's Pancake House to possibly help serve the food, but Frances suggested that we continue to serve ourselves to keep the expenses down.

<u>YOUTH AWARD</u>: In past years it has been very difficult to get nominees for this event so the committee members voted to remove this category this year.

Jeannie Gordon suggested a New Category for our Spirit Awards next year to include Business People. After some discussion, this idea was tabled for future discussion. Jerry Smith questioned about having the Sandy Bottom Beach Boys play again this year but a vote was taken to just have C.D. music in the background. We felt that the people were not paying enough attention to the music but rather wanted to chat with friends and neighbors. The Decorating Committee will be responsible for background music such as C.D.'s.

We were reminded that the deadline for nominees will be: FEBRUARY 28

Nancy Hughes questioned whether anything was done about finding if we can lock the message board in light of the constant messing around with the messages. Frances said she will check with Sonny Beeker about possibly coming up with a way to lock the board. Apparently if we were to go back to the vendor who installed the board, it would be quite expensive.
