

## **KURE BEACH COMMUNITY CENTER OCTOBER 12, 2010 MINUTES**

The October 12, 2010 meeting of the Kure Beach Community Center Committee was called to order at 10:04 a.m. Members present were Jean Martin, Charlotte Philemon, Lore Eccleston, Pam Bramhall, Nancy Hughes, and Donna Budd. Newly appointed Town Council Member, Emilie Swearingen attended the meeting.

Jean Martin began the meeting with a prayer for guidance and wisdom in our discussions and decisions and blessings and safety for all. The September minutes were approved.

Our treasurer, Jeannie Gordon, was absent but sent the financial report with Jean Martin.

Discussions were as follows.

### **COMMUNITY CENTER REPLACEMENT LIGHTS**

### **KURE BEACH 2011 COMMUNITY SPIRIT AWARD NOMINATIONS AND DINNER**
