

**KURE BEACH COMMUNITY CENTER**

The January 10 meeting of the Kure Beach Community Center Committee was called to order at 10:00 a.m. Members present were Charlotte Philemon, Jean Martin, Jeanne Gordon, Donna Budd, Lore Eccleston, Connie Mangum, Harriet Owsley, and Chuck Keener; Town Council Representative, attended the meeting.

Community Center membership candidate, Glenda Dodge, attended the meeting and her application was unanimously approved by Committee members. She is to be confirmed as a Committee member at the February Town Council meeting on February 21, 2012.

Charlotte called the meeting to order with a prayer for guidance and wisdom in our discussions and decisions and blessings for all. The January 10, 2012 minutes were approved.

Jeanne gave the treasurer's report bringing committee members up-to-date with her usual outstanding report regarding the financial status of the Community Center budget.

**OLD BUSINESS**

Discussion ensued regarding additional places to advertise Community Center activities and events, and the committee decided to look into posting events on the both of the Center's inside and outside message boards. Chuck will look into ideas for postings on the Town's website.

**Ongoing Issues Regarding Ballet/Jazz Class**

Jeanne reported on information regarding activities that she observed when recently visiting the Community Center while a ballet/jazz class was being held. We have had ongoing problems that continue with this class regarding children waiting in the meeting and kitchen areas who are not being monitored. We all agreed that this situation should be addressed as soon as possible. The Committee voted to revise our General Provisions policies to address the situation. Chuck will also discuss the situation with Dean, who will advise the Chair of Parks and Recreation of the problem.

## **NEW BUSINESS**

### **Purchase Of New Coffeemaker**

Discussion ensued regarding the need for a new coffeemaker for the Center and the Committee voted to buy one. Lore and Harriet volunteered to purchase one.

### **Garden Lecture Series**

Charlotte presented a report on information regarding a series of educational lectures by the North Carolina Cooperative Extension's Speakers Bureau Programs using speakers from the Extension's Master Gardeners program to be presented by the Community Center, After discussion, it was agreed for her to look into scheduling one.
