*OLD BUSINESS:*

- 1. The committee still needs one additional member.*
- 2. Items 1 – 5. DOT has been notified and we are waiting for their input and approval.*
- 3. TDA involvement for parking map. Tony will attend the Marketing committee meeting on Oct 14<sup>th</sup> along with Jim Smith to discuss our ideas for the map. Marketing's primary concern is "heads in beds" and SLAP's primary concern is beach access and parking. Hopefully a joint venture will cover both of these concerns.*
- 4. Joe Eakes Park, parking. Jim and Priscilla Smith surveyed the area from Joe Eakes Park to the pump station. They measured the area to ascertain how many spaces would be viable. They took into consideration the size of the required spaces, the addition of space for handicap, the amount need for pulling in and out of the space. The total amount of spaces came to 96. Keep in mind that these figures can be changed drastically depending on where the bathrooms will be placed.*

*NEW BUSINESS:*

- 1. Joe Eakes Parking and Corral Parking. Tony has made contact with the Lanier Parking Solutions for their input. This group handles the paid parking for Carolina Beach and Wrightsville Beach. Lanier is aware that we have no plans to implement paid parking. We need their expertise in implementing the parking in these two areas.*
- 2. "P" parking signs. We would like to use 4x4 for the parking signs, pending approval by the DOT.*
- 3. Cross Walks. We are still waiting for DOT to give their approval.*
- 4. Ocean Front Park. The design for the park has been approved for the final drawing. Not everyone is pleased with the design.*

*The meeting was adjourned at 6:00PM. The next scheduled meeting will be on November 3<sup>rd</sup> at 5:00PM at the Town Hall.*
