- 5. The encroachment process for new parking on K is in process.*
- 6. Obtaining an additional crosswalk at Ave. M is in process.*
- 7. Beach Access Wood Signs project is waiting for the sample from September Signs.*
- 8. Bring before Council. Withers and Ravenel to design J-E beach access.*
- 9. By motion made, seconded and carried the Committee will bring before Council permission to purchase on Beach Wheelchair for the amount, not to exceed \$2500.00.*

*NEW BUSINESS:*

- a. Discuss summer schedule. By motion made, seconded and carried the Committee voted to not hold a meeting in July and August. If something comes up that needs attention the committee will readdress this.*
- b. The committee's present liaison has difficulty in attending our meetings. We are requesting liaison whom is able to attend all meetings.*
- c. Sidewalks on Ave K. This is a new project that the Committee will address in the future.*
- d. Paid Parking. The committee has been asked three times to investigate paid parking in Kure Beach by individual members of the Council. Each time, after lengthy investigation, the Council has rejected the idea. We would appreciate any further requests be made by at least the majority of the council.*
