*By motion made, seconded and carried the agenda for the November meeting were adopted.*

*OLD BUSINESS:*

- 1. TDA This project is still on-going*
- 2. K Ave sidewalk. This project should start in November. The plan is to install the drainage, then the curbs and then the sidewalk.*
- 3. Coral Parking. This is still on hold pending the completion of the sidewalk.*
- 4. J & E beach access parking changes. This is on hold.*
- 5. Installation of the new signs. Some have been installed and we are waiting for the rest to be installed. The Beach Protection Committee is also concerned about the missing signs. The Fines for violations cannot be enforced if the signs are not in place.*
- 6. Parking spaces along Ft. Fisher Blvd. There is a possibility that Ft. Fisher Blvd will be repaved. We are on hold until we get additional information from DOT.*
- 7. Volunteer thank you from Council. This is in limbo.*

*NEW BUSINESS:*

- a. New member application. The Committee, by motion made, seconded and carried voted to accept Beth Yaccarino as a new member. The Committee also voted to increase the number of members from five (5) with one (1) Alt, equaling a total of six (6) members to six (6) members plus one (1) Alt. Equaling a total of seven (7).*
- b. Cigarette Butts Signage for 24 beach accesses. Tony will bring to council the request to purchase the materials to create 24 Cigarette Butt collection posts. The cost is \$2.00.00 for 24 posts and a group of volunteers will make the posts. The will give them to Public Works for installation on the beach.*
- c. Beach Protection merge. Andy from the Beach Protection Committee has asked for his committee and the SLAP Committee to merge into one entity. There are three members who are on both committees. Many of the projects that SLAP deals with are also concerns of the Beach Protection Committee and the members feel it would be beneficial*

*to both committees to work together as one. By motion made, seconded the Committee voted to merge with the Beach Protection committee if the Council agrees.*

*The meeting was adjourned at 5:50PM. The next scheduled meeting will be on January 7<sup>th</sup> at 5:00PM at the Town Hall. The time of the meeting may be changed due to the merger and all members will be advised of any changes.*
