### **PRESENTATIONS**

Jim Kennedy, Executive Officer, Cape Fear Sail & Power Squadron stated requesting Town Council to adopt the Proclamation presented. The primary goal is to always promote safe boating in our area. Each year train over 150 new boaters to keep them safe on the water and inspect over 200 recreational vessels to make sure they have all their safety gear. 80% of deaths on the water are caused by drowning where 86% of drowning cases, the victim was not wearing a life jacket.

- 3. Planning & Zoning Commission
  - Action and Consideration on Proposed Text Amendments to Proposed Text Amendments to KBC Chapters 5, 6, and 7

PZC Chairman Ashbridge stated tonight have proposed text amendments for Town Council to review and approve. Chapters 5, 6, and 7 are mostly grammatical/syntactical revisions. A few amendments that are further beyond that. Section 05.06 deals with massage establishments and has very outdated language and the Town Attorney has recommended the Town refers to state regulations. KBC 5.02.040 prohibits any kind of dancing at an establishment that sells beer, so the revision is to delete. There is also current language that prohibits any type of open-air bar so it has been recommended to delete.

MPT Heglar stated Public Works Director Mesimer and himself met with Member Barlok and went through Chapter 7, and he appreciates all Member Barlok's work on this project. The Public Works Department agrees with all the recommended changes.

SLABP Chairman Jackson stated it would be up to Kure Beach. The Town Council would control it.

Dick Brightman, Chairman of Keep New Hanover Beautiful stated he spent the whole day in Carolian Beach today and the group handled the permit process and the letters to the adjacent property owners in Carolina Beach. The agreement would be that Keep New Hanover Beautiful is the contractor and the Town is the applicant. The frequently, time of day is totally up to the Town.

MPT Oliver asked do you have insurance coverage?

Dick Brightman, Chairman of Keep New Hanover Beautiful stated that question has not been raised by Carolina Beach or Wrightsville Beach.

CONSENUS- Town Council agreed for Attorney Eldridge to review the CAMA permit agreement and have Keep New Hanover Beautiful look into insurance

SLABP Chairman Jackson gave a presentation on "Beach Toy Boxes" that is hereby incorporated into the minutes.

MPT Heglar stated he would like SLABP Chairman Jackson to discuss with Ocean Rescue and Carolina Beach about their program.

Fire Chief Kennedy stated the Department will be holding 3 upcoming lifeguard tryouts over the next 3 weekends. Also just selected the 4 winners for the two scholarship programs from the Fire Department and will host a meeting on May 20<sup>th</sup> at the Fire Department at 7:00 p.m. to award them to the winners.

### DISCUSSION AND CONSIDERATION OF OLD BUSINESS

1. Discussion and follow up of Seagull Ordinance

Mayor Oliver stated a memo is included in the agenda packet that Lieutenant Bailey did research for Town Council. He has heard from 6-8 individuals requesting an ordinance. Carolina Beach has an ordinance against feeding wildlife. Sunset Beach has an ordinance for water birds. He reached out to the National Wildlife Resource Commission that provided information on how its not healthy to feed wildlife. Town Council needs to make the decision does the Town want an ordinance.

MPT Heglar commented if citizens are being inconvenienced than Town Council should address it. He wants the police to have the authority when a person is being harassing. He thinks the Town Council should give them an ordinance for when citizens are being harassing. This would be compliant driven.

Mayor Oliver commented yes he would want it to be complaint driven.

Commissioner Mearkle stated she agrees.

Commissioner Panicali stated in the code there is currently a provision that states "no one shall feed any non-domesticated animal in any park". As he reads what other Towns have done may just modify to not feed any non-domesticated animal or bird.

Attorney Eldridge stated need to be careful an ordinance as that will reach all the way to backyard bird feeders. The Town could draft an ordinance very specific to seagulls on the beach or look at the nuisance ordinance and add a statement there. He thinks making it specific to the beach strand would be better for the Town.

CONSENUS- Town Council agreed for Attorney Eldridge to draft an ordinance that is compliant driven regarding feeding seagulls on the beach strand.

Honorable Mayor Oliver and commissioners,

What a great month we have to report on!

- First of all, we received a grant from NCDOT for 25 children's helmets which will be given out at the Traffic Garden on May 17. What is so exciting about this, is the fact that MAY IS BIKE MONTH and we are joining 'BIKE TO SCHOOL DAY' with Carolina Beach Elementary School, leaving Joe Eakes Park at 7:15am to arrive at school by 7:45. Chief Bowdin is aware, and we invite you, Mayor, commissioners and any other parents and children who want to bike together to the school. Then that day we are presenting a Traffic Garden for the second graders, about 80 students in all, to learn safety practices focusing on safety practices like stopping for pedestrians in crosswalks, learning how to read street signs and bicycle ABC's. This is also being used as the pilot program 'Let's go NC' a Statewide safety based curriculum which we would like to see instituted in the school in the future.
- Why is the crosswalk component so important to us? Because last week, after 4 years of auditing, planning, finding funding and getting on NCDOT's schedule we finally have the first 4 lighted crosswalks installed on Ft. Fisher Blvd at 1004.5 (near Ocean View), M by the post office, Blakeslee Air Force Rec Area, and Surf Rider near Ocean Dunes.
- A PSA about Pedestrians having the right of way in a crosswalk was posted by the Kure Beach Recreation FB page.
- Our committee will have a booth focusing on education at the Kure Community Fest. Our campaigns are "Be Safe, Be Seen" and "Heads Up, Phones Down."
- We were also asked by a resident if we could have a FUN RIDE. For Bike Month we are planning a bike ride on May 19th. The ride will start at 1pm from the Town Hall parking lot. More information to follow.
- Join the Kure Krusiers on Saturday June 15th in Burgaw for the Tour de Blueberry Bike Ride. Choose your distance (10, 22, 33, or 66 mile ride) and select the Kure Kruisers as your team! Complete the sign up and waiver on the committee website. Both forms need to be completed to ride in this event. Be sure to check out the festival afterwards!



### May is Bicycle Awareness Month

WHEREAS, the month of May is observed as National Bike Month, and the Kure Beach Town Council is committed to the promotion of safe and convenient bicycling for both transportation and recreation; and

WHEREAS, the Town of Kure Beach is committed to promoting the safe use of bicycles on the Town's streets and trails through planning and project activities that include the Kure Beach Bicycle and Pedestrian Plan in 2022, the ongoing Island Greenway Paved Trail Feasibility Study, and design of pedestrian safety improvements at the intersection of Fort Fisher Boulevard and K Avenue, and

WHEREAS, the Town of Kure Beach supports education about bicycle safety through the Wilmington Urban Area Metropolitan Planning Organization's (WMPO) Be A Looker campaign which encourages children and adults to operate their bicycles in a safe manner and educates drivers on how to share the road with bicyclists; and

**WHEREAS**, the Kure Beach Town Council is committed to alleviating traffic congestion by providing choices in transportation infrastructure and ensuring a clean and healthy environment.

**NOW, THEREFORE, BE IT PROCLAIMED** that the Kure Beach Town Council hereby proclaims May as Bicycle Awareness Month and will continue to promote safe cycling opportunities for Kure Beach's citizens.


