Attorney Eldridge stated that during closed session Council discussed several matters involving legal issues, and no actions or votes were taken.

MPT Heglar commented regarding the two contractors the Town will be using venders that Carolina Beach did RFPs with in the spring. Per FEMA guidelines it is very regulated, and the Town wants to make sure the Town is reimbursed if the state declares a State of Emergency. One of the contracts is for a monitoring company that monitors every load of debris. The goal is to approve both contracts tonight and these contracts are currently at the state level to be approved. His recommendation is to approve for the Mayor to sign with the understanding the state approves the contract language.

MOTION – MPT Heglar made a motion to authorize the Mayor to sign the following contracts as long as the language is approved by the State: Monitoring contract with Raston LLC, and a contract with CTC Disaster Response for storm debris removal and pickup SECOND – Commissioner Ellen
