**5.06.030 Operation of Mobile Ice Cream Vehicles**

Mobile ice cream vehicles being operated within the Town are subject to the following limitations:

- A. All sales shall be conducted during daylight hours
- B. The duration of a mobile ice cream stop shall not exceed 20 minutes
- C. A mobile ice cream vendor shall not operate, stop, or conduct any sales: i) anywhere within the B-1 Business District; ii) at any point on Fort Fisher Boulevard; iii) At any Beach Access location; iv) or at any point on a public right-of-way abutting the beach.

**This IC Permit is valid for one calendar year from issue.**

**Each applicant is subject to a Drivers History, Background Check and Criminal Background check. This information will not be disseminated.**
